TDCJ Units with full, partial and NO airconditioning **August 2023**

According to TDCJ, All TDCJ units have air conditioning in the administrative, education, and medical areas of the unit. The units we describe as partially air-conditioned have air conditioning in part, but not all of the housing areas. While TDCJ has some prototype units, the design of each unit and the areas that are air conditioned varies due to the date and the purpose at the time of construction. There are about 15,000 air-conditioned beds in the units that are described as partially air conditioned in 2021. TDCJ currently has 100 active units, with 70 units having partial to no air conditioning, and 9 units that are over 100 years old. The following information is based on information requests from 2018-August 11, 2023 and TDCJ Website.
